

**THE KARACHI DEVELOPMENT AUTHORITY
(AMENDMENT) ORDER-1962.**

President's Order No. 6 of 1962

(27th March, 1962)

Whereas it is expedient further to amend the Karachi Development Authority Order, 1957 (P. O. No. 5 of 1957), for the purposes hereinafter appearing :

Now, THEREFORE, in pursuance of the Proclamation of the seventh day of October, 1958, and in exercise of all powers enabling him in that behalf, the President is pleased to make the following Order :—

1. *Short title and commencement.*—(1) This Order may be called the Karachi Development Authority (Amendment) Order, 1962.

(2) It shall come into force at once.

2. *Amendment of preamble and certain Articles of President's Order No. 5 of 1957.*—In the Karachi Development Authority Order, 1957 (President's Order No. 5 of 1957), hereinafter referred to as the said Order :—

(i) for the word "Federal Territory of Karachi" wherever occurring the words "Karachi Division" shall in all places be substituted ; and

(ii) for the words "Central Government" wherever occurring, except in Articles 1, 3, 8, 20, 87, 98, 104, 117 and 120, the words "Provincial Government" shall in all places be substituted.

3. *Amendment of Article 8, President's Order No. 5 of 1957.*—In the said Order, in Article 8, for the words "Central Government" wherever occurring, except in the proviso to clause (1), the words "Provincial Government" shall in all places be substituted.

4. *Insertion of new Article 13A, President's Order No. 5 of 1957.*—In the said Order, after Article 13, the following new Article 13A shall be inserted, namely :—

"13A. *Power of Authority to undertake work entrusted to it by Central Government.*—(1) Notwithstanding anything contained in this Order, the Authority may, upon such terms and conditions as may be laid down by the Central Government undertake and execute any housing scheme of the Central Government entrusted to it by that Government.

(2) The Authority shall comply with all instructions issued to it from time to time by the Central Government in relation to the schemes entrusted to it.

(3) Necessary funds shall from time to time be placed by the Central Government at the disposal of the Authority for the execution of the Schemes entrusted to it.

(4) The Authority shall render complete accounts of the funds advanced to it by the Central Government under clause (3).

(5) It shall be open to the Central Government to authorise the Comptroller and Auditor General of Pakistan to conduct a test or other audit of the account submitted to it on such terms and conditions as the Central Government may determine.

(6) The Authority shall submit to the Central Government progress reports in respect of the schemes entrusted to it by that Government and such other reports as the Central Government may require from time to time.

5. *Amendment of Article 17, President's Order No. 3 of 1957.*—In the said Order, in Article 17, clause (2) shall be omitted.

6. *Amendment of Article 20, President's Order No. 3 of 1957.*—In the said Order, in Article 20, for the words "Central Government" occurring at the end, the words "Provincial Government" shall be substituted.

7. *Amendment of Article 25, President's Order No. 3 of 1957.*—In the said Order, in Article 25, in clause (1), for the words, figures, comma and brackets "persons holding certificates under section 144 of the Companies Act, 1913 (VII of 1913)," the words, comma, figures and brackets "Chartered accountants within the meaning of the Chartered Accountants Ordinance, 1961 (X of 1961)" shall be substituted.

8. *Amendment of Article 87, President's Order No. 5 of 1957.*—In the said Order, in Article 87, for clause (3) the following shall be substituted, namely:—

"(3) Notwithstanding the provisions of clauses (1) and (2), no land or building vested in the Central Government or a Provincial Government shall be taken possession of as aforesaid without the previous sanction of that Government, nor shall any land or building vested in any Corporation incorporated by any law for the time being in force be taken possession of as aforesaid without the previous sanction of the Provincial Government".

9. *Amendment of Article 98, President's Order No. 5 of 1957.*—In the said Order, in Article 98, for the words "Central Government", wherever occurring, except in clause (1), the provision to sub-clause (i) of clause (3) and sub-clause (ii) of clause (3) the words "Provincial Government" shall in all places be substituted.

10. *Amendment of Article 104, President's Order No. 5 of 1957.*—In the said Order, in Article 104, in clause (3), for sub-clause (a) the following shall be substituted, namely:—

"(a) the Central Government or the Provincial Government in respect of any land which is the property of, or is managed by the Central Government or, as the case may be, the Provincial Government".

11. *Savings.*—Any rule, order or appointment made, any notification issued, any sanction or direction given, any funds placed or any other thing done or any action taken or any proceeding commenced by the Central Government before the commencement of this Order under any provision of the said Order, wherein for the words "Central Government" the words "Provincial Government" have been substituted by this Order, shall be deemed to have been made, issued, given, placed, done, taken or commenced by the Provincial Government under the said provision as amended by this Order and shall have effect accordingly.
