No. PAWP/Legis-(24)/66/69-The Karachi Development Authority (Amendment) Bill, 1966, having been passed by the Provincial Assembly of West Pakistan on the 4th day of July, 1967 and assented to by the Governor of West Pakistan on the 15th day of July, 1967, is hereby published as an Act of the Provincial Legislature of West Pakistan.

to amend the Karachi Development Authority Order, 1957.

WHEREAS it is expedient to amend the Karachi Development Authority Order, 1957, Preamble
(President's Order No. 5 of 1957) in the manner hereinafter appearing;

It is hereby enacted as follows :-

| 2. After Article 27 of the Karachi Development Authority
Order, 1957, the following shall be added, namely :- | Addition of Article
27-A in President's Order
No. 5 of 1957. |

27-A (1) The Statement of Accounts of the Authority referred to in clause (2) of article 25 together with the report of the Comptroller and Auditor-General of Pakistan, if any, on the test or other audit made under clause (3) thereof and the annual report referred to in Article 27 shall be laid before the Provincial Assembly of West Pakistan as soon as may be following the receipt thereof by the Provincial Government, and the Provincial Assembly shall refer the same to its Committee on Public Accounts for scrutiny.

(2) The Committee on Public Accounts shall scrutinize and examine the reports referred to it under sub-section (1) in the same manner as, and shall in respect thereof perform the same functions and exercise the same powers as, are required by it to be performed and exercised in respect of the Appropriation Accounts of the Provincial Government and the report of the Comptroller and Auditor-General of Pakistan thereon.

(3) The Authority shall produce such documents and furnish such explanation and information to the Committee referred to in sub-section (1) as the Committee may require at the time of examination of the Accounts.

(4) Government may require the Authority to furnish it with-

- (i) any return, statement, estimate, statistics or other information regarding any matter under the control of the Authority; or
- (ii) a report on any such matter; or
- (iii) a report on any document in the charge of the Authority; and the Authority shall comply with every such requisition."
