- ii. Firm must possess valid license from Pakistan Council of Architects and Town Planners (PCATP) in Architecture category Attach attested copy.
- iii. Firm must have an average annual turnover of PKR 50.00 million during last 02 years. (In case of a Joint Venture, Lead Firm must have average annual turnover of PKR 50.00 million during last 02 years whereas other JV member(s) must have average annual turnover of PKR 10.00 million individually during last 03 years) Attach attested photocopy of audit report for each year.

- iv. Firm must possess registration with FBR and Sindh Revenue Board
- v. Availability of at least 02 Qualified Architect possessing Registration with both PCATP and SBCA and having over 25 years of experience Attach attested evidence.

Firms / JVs, not fulfilling the above mandatory requirements, EOI of the Firms / JV will not be evaluated further and declared non-responsive.
