

4. The bid security equal 5% of Bid Amount in shape of pay order from any scheduled bank in favor of **Karachi Development Authority** must be enclosed with tender documents; otherwise the tender will be rejected.
5. That Bidder who shall fulfill the entire Eligibility Criteria or Mandatory requirement shall be declared substantially responsive bids at the time of tender opening and will be eligible for further evaluation; otherwise the tender will be declared as non-responsive / rejected.

7. The contractors must mention their complete and correct present / postal address in tender documents and quoted the rates both in words and in figures incomplete / conditional tenders will be not accepted.
8. If any fake documents are found then the tender is liable to be rejected / cancelled without any compensation with penalty as per rules.
9. In case, the date of opening declared as a public holiday by the Government, or non-working day due to any reason the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.
