 - Bid tender in sealed covers mentioned name of work and submit their proposals in two separate envelopes clearly marked as " Technical Proposal" and "Financial Proposal" Offer Should be dropped in the tender box kept at the place and time mentioned above.
 - Initially, the technical proposals will be opened by the Tender Opening Committee on the date and time mentioned above, whereas the financial proposal will be retained with Chairman Procurement Committee till evaluation of the technical Proposals.
 - In case, due to any reason, no tenders are received on the above dates then the next date of submission and opening will be **05-07-2023** and accordingly the tender documents will be available for sale upto **04-07-2023** (during office hours).
 - The technical proposals submitted by the bidders will be evaluated by Procurement Committee as per evaluation criteria and mandatory requirements given in the Technical Proposal and thereafter financial proposals of technical qualified bids will be opened by the same Committee on the date and time to be communicated to the bidders.

6. The financial proposal of the bids found technically non-responsive shall be returned unopened to the respective bidders.
7. In-case the date of opening or last date of sale of tender is declared as a public holiday by the Government or non-working day due to any reason, the next working day(s) shall be deemed to be the date for last date of sale and submission and opening of tenders accordingly. The time and venue shall remain the same.
8. **Bid Security:-** Bid Security as mentioned above in shape of pay order or bank guarantee (on specified Performa) attached with the Technical Offer in favor of **Karachi Development Authority** shall be enclosed as follows:-
 - a) 25% of bid amount shall be enclosed with Technical Offer Envelope as part of Bid Security Otherwise the bid will not be evaluated.
 - b) Balance Bid Security Amount after deducting Rs. 25% of bid amount shall be enclosed with Financial Offer Envelope in case of non compliance, the part of Bid Security attached with the technical offer shall be forfeited.
 - c) The Bid Security of qualified and non qualified both will be retained till finalization to award of work.
9. The competent authority reserves the right to reject any or all proposals subject to the relevant provision of SPPRA Rules.
10. Canvassing in connection with tendering is strictly prohibited and proposals submitted by the contractors who are reported to be involved in canvassing are liable for rejection.
