If failed, sealed tenders will not be considered.

9. The bid security equal to 5% of the amount of the bid will be paid in any scheduled form in favour of Karachi Development Authority and be enclosed with tender documents, otherwise the tenders will be rejected.

10. The contractor must mention their complete and correct present / postal address in tender documents & quote the rates both in words & in figures. Incomplete / Conditional tenders will not be accepted.

11. If any bid also contains and found then the tender is liable to be rejected / cancelled without any compensation & with penalty as per rules.

12. Discussing in connection with tenders is strictly prohibited and tenders submitted by the contractor who are reported to be involved in discussing will be liable for rejection.

13. All the tenders will be dropped as per above schedule up to 11:00 am and will be opened by the Procurement Committee, at the Office at the above-mentioned at 11:30 am in presence of each contractor / parties / firms / bidders who wish to be present.
