2. In case of any reasons, if the tenders are not responded on the above date, the next date of submission and opening of bids will be 12-02-2024 and the tender documents will also be available up to 09-02-2024

The biding documents will be issued to the interested firm/contractors on submission of written request on original letter head from the owner of the firm on payment of non-refundable cost of tender price mentioned against each work, through call deposit/pay order on any scheduled bank in favor of Karachi Development Authority and biding document can also be downloaded from the SPPRA website (https://ppms.pprasindh.gov.pk/PPMS/) with tender fee mentioned as above.

- 4. The bid security equal 2% of Bid Amount in shape of pay order from any scheduled bank in favor of Karachi Development Authority must be enclosed with tender documents; otherwise, the tender will be rejected.
- 5. The contractors must mention their complete and correct present / postal address in tender documents and quoted the rates both in words and in figures incomplete / conditional tenders will be not accepted.
- 6. If any fake documents are found then the tender is liable to be rejected / cancelled without any compensation with penalty as per rules.
- 7. Canvassing in connection of tenders in strictly prohibited and tenders submitted by the contractors who are reported to be involved in canvassing will be liable for rejection.
- 8. All the tenders will be dropped on as per above schedule up to 11:00 am and will be opened by the Procurement Committee, in the office of the undersigned at 11:30 am in presence of such contractors / parties / firms/bidders who wish to be present.
- 9. In case, the date of opening declared as a public holiday by the Government, or non-working day due to any reason the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.
- 10. The procuring agency may reject all or any bids/tenders at any time prior to the acceptance of a bid or proposal subject to the relevant provision of SPPRA Rules 2010 (amended time to time).
- 11. Tenders will not be received after the schedule time.

### 12. Eligibility Criteria:-

- a. Valid NTN Certificate
- b. Valid SRB Registration Certificate.
- c. Average Annual turnover of at least 20 million duly supported by the Bank Statement & Audit report (last 3 years).
- d. Proof of relevant experience and details of at least one work amounting to Rs. 16 Million executed/being executed since last 3 years indicating the name of project/scheme/works with cost, date of commencement & completion. OR Proof of relevant experience and details of at least two works amounting to Rs. 10 Million executed/being executed since last 3 years indicating the name of project/scheme/works with cost, date of commencement & completion.
- e. Valid PEC and Category relevant field of specialization codes (where applicable).
- f. Affidavit / Undertaking regarding Firm never been black listed *OR* not involved in any Court Case/Litigation with any Government/Semi Government Department.
- g. Copy of CNIC
- h. All original documents must be shown upon the request of the procurement committee for verification.
