2. In case of any reasons, if the tenders are not responded on the above date, the next date of submission and opening of bids will be **09-06-2023** and the tender documents will also be available up to **08-06-2023 on the same time as mentioned above**
3. The tender documents will be issued to the interested firms / Contractor / Joint Ventures on submission of application in their original letter head along-with pay-order from any schedule bank in favor of **Karachi Development Authority** for tender cost as mentioned above (nonrefundable). Tender downloaded from SPPRA web site (<https://ppms.pprasinhdh.gov.pk/PPMS/>).
4. The tender in sealed covers mentioning name of work and submit their proposals in two separate envelopes clearly marked as **“TECHNICAL PROPOSAL”** and **“FINANCIAL PROPOSAL”** offer should be dropped in the tender box kept at the place and time mentioned above.
5. Initially the technical proposals will be opened by the Tender Opening Committee on the date and time mentioned above, whereas the financial proposal will be retained till evaluation of the technical proposals.
6. That Bidder who shall fulfill the entire Eligibility Criteria or Mandatory requirements shall be declared substantially responsive bids at the time of tender opening and will be eligible for further evaluation; otherwise the tender will be declared as non-responsive / rejected.
7. The Contractors must mention their complete and correct present / postal address in tender documents and quoted the rates both in words and in figures. Incomplete conditional tenders will not be accepted.
8. If any fake documents are found then the tender is liable to be rejected / cancelled without any compensation with penalty as per rules.
9. The technical proposals submitted by the bidders will be evaluated by Procurement Committee as per evaluation criteria and mandatory requirements given in the Bidding Data and thereafter financial proposals of technically qualified bids will be opened by the same Committee on the date and time to be communicated to the bidders.
10. The financial proposals of the bids found technically non-responsive shall be returned unopened to the respective bidders.
11. In case the date of opening or last date of sale is declared as public holiday by the government or non-working day due to any reason, the next working day shall be deemed to be the date for last date of sale and submission and opening of tenders accordingly. The time and venue shall remain the same.

12. **Bid Security:**


Bid Security in shape of pay-order in favor of KDA shall be enclosed as follows: -

- a) Rs. 25,00,000/- shall be enclosed with Technical Proposal as part of Bid Security. Otherwise the bid will not be evaluated.
- b) Balance Bid Security Amount (after deducting Rs. 25,00,000/-) shall be enclosed with Financial Proposal. In case of noncompliance, the part of Bid Security attached with the technical proposal shall be forfeited.
- c) The Bid Security of qualified and not qualified both will be retained till finalization to award of work.

13. The competent authority reserves the right to reject any or all proposals subject to the relevant provision of SPPRA Rules 2010 (amended 2019).
14. Canvassing in connection with tendering is strictly prohibited and proposals submitted by the contractors who are reported to be involved in canvassing are liable for rejection.
15. The proposals received in unsealed covers will not be entertained and no proposal will be received after schedule date and time.
16. Tenders will not be received after the schedule time.
17. All corrections / overwriting shall be clearly Re-written with Initials and duly stamped by the Bidder.
18. All clauses of Bidding Data Eligibility Criteria and Mandatory Criteria mentioned in tender / bidding documents shall have same priority and non-fulfillment of any of clause shall lead to bid rejection / disqualification.

Note

All the terms / conditions and eligibility criteria mentioned in the Technical Proposal should be complied strictly because evaluation of the bid and success of the bidder shall be based on document / evidence provided by the bidder as required in the technical proposal.
