

- In case of any reasons, if the tenders are not responded on the above date, the next date of submission and opening of bids will be 12-02-2024 and the tender documents will also be available upto 09-02-2024.
- 3. The bidding documents will be issued to the interested firms / contractors on submission of a written request on original letterhead from the owner of the firm on payment of non-refundable cost of tender mentioned against each work, through call deposit / pay order of any scheduled bank in favor of Karachi Development Authority and bidding document can also be downloaded from the SPPRA website (https://ppms.pprasindh.gov.pk/PPMS/) with tender fee mentioned as above.
- 4. The bid security equal to 2% of Bid Amount in shape of pay order from any scheduled bank in favor of Karachi Development Authority must be enclosed with tender documents; otherwise the tender will be rejected.
- Thecontractorsmustmentiontheircompleteandcorrectpresent/ postal address in tender documents and quote the rates both in words and in figures, Incomplete / conditional tenders will not be accepted.
- If any fake documents are found, the tender is liable to be rejected / cancelled without any compensation with penalty as per rules.
- Canvassing in connection with tenders is strictly prohibited and tenders submitted by the contractors who are resorted to be involved in canvassing will be liable for rejection.
- All the tenders will be dropped on as per above schedule upto 11:00 am and will be opened by the Procurement Committee in the office of the undersigned at 11:30 am in presence of such contractors / parties / firms / bidders who wish to be present.
- In case the date of opening is declared as a public holiday by the Government, or non-working day due to any reason, the next official working day shall be deemed to be the date for submission and opening of tenders at the same time.

- The Procuring Agency may reject all or any bid/tender at any time prior to the acceptance of a bid or proposal subject to the relevant provision of SPPRA Rules 2010 (amended time to time).
- 11. Tenders will not be received after the schedule time.

Eligibility Criteria

- a. Valid NTN Certificate
- b. Valid SRB Registration Certificate.
- Average Annual turnover of at least 20 million duty supported by the Bank Statement & Audit Report (last 3 years).
- d. Proof of relevant experience and details of at least one work amounting to Rs. 16 Million executed / being executed since last 3 years indicating the name of project / scheme / works with cost, date of commencement & completion OR proof of relevant experience and details of at least two works amounting to Rs. 10 Million executed / being executed since last 3 years indicating the name of project / scheme / works with cost, date of commencement & completion.
- Valid PEC and Category relevant field of specialization codes (where applicable).
- Affidavit / Undertaking regarding firm never been blacklisted OR not involved in any Court Cases / Litigations with any Government / Semi Government Department.
- g. Copy of CNIC
- All original documents must be shown for verification upon the request of the Procurement Committee.
